Introduction

The following tables illustrate Amplify ELA's correlation to Indiana's Academic Standards for English/Language Arts relative to ILEARN Checkpoints and Summative Assessments. Teachers will find this document to be helpful when planning and preparing for ILEARN assessments to ensure student achievement and growth according to academic standards. Teachers have quick access to tables arranged by grade levels, testing periods, standards, and units.

Testing Periods: Students will have three checkpoints and a final summative assessment over the course of one academic school year.

Standards Coverage: Each standard listed in the following tables is addressed within the course of a 180-lesson plan. Amplify ELA's standards-aligned core units of instruction are designed to help students build content knowledge and literacy skills throughout a school year. Additionally, teachers can use Amplify ELA's flexible units and resources at any time to provide standards coverage. One of these resources, the Vocab App, is embedded in most core lessons, meaning students will use it regularly to practice key vocabulary skills.
